In view of the auditee, the auditee consisted of two 3-storey buildings used as office, workshop and warehouse, two flat buildings used as warehouse, one flat building used as workshop and one flat buildings used as sundry warehouse (the warehouse was empty on audit days). All the buildings were rented from the landlord named Xinzhai Village Committee. The auditee provided lease contract for review.
- 5. The main products manufactured by the auditee were garments.
- 6. All 97 employees were local from Hebei Province. No migrant employee was in the auditee.
- 7. 12 months' (from May 2021 to April 2022) payroll records and 13 months and 22 days' (from May 1, 2021 to June 22, 2022) attendance records were reviewed. 10 samples were selected from April 2022 (current month), December 2021 (random month) and October 2021 (random month) respectively.
- 8. No peak season in the auditee.
- 9. According to the attendance records provided by the auditee: 1) For April 2022 (current month), the average number of hours worked in a week for the 10 randomly selected samples were 50 hours per week. Maximum working hours per week were 52 hours (10 out of 10 randomly selected samples); 2) For December 2021 (random month), the average number of hours worked in a week for the 10 randomly selected samples were 50 hours per week. Maximum working hours per week were 52 hours (10 out of 10 randomly selected samples); 3) For October 2021 (random month), the average number of hours worked in a week for the 10 randomly selected samples were 52 hours per week. Maximum working hours per week were 52 hours (10 out of 10 randomly selected samples).
- 10. The local minimum wage standards set at RMB 1680 per month, equivalent to RMB 9.66 per hour since November 1, 2019.
- 11. Wages of employees were calculated based on hourly-rate basis. Wages of employees were paid by cash.
- 12. Some documents were not uploaded because of following reasons:

There was no contractor used by the auditee, so contractor license/permit was not applicable.

There was no agency used by the auditee, so agency labor contract was not applicable.

There was no waiver obtained by the auditee, so government waiver was not applicable.

There was no collective bargaining agreement existed in the auditee, so collective bargaining agreement was not applicable.

- 13. The COVID-19 risk of the area the auditee located was defined as a low risk by government. Local government did not require companies to adopt the prevention and control measures. #COVID-19
- 14. Fire drill was conducted twice per year in the auditee and the latest one was conducted on May 20, 2022.
