

GIFT CARDS

Terms and Conditions

1. Leokid Gift Cards can be purchased at the Leokid online store www.leokid.com .

By purchasing and using the Gift Cards the Gift Card Purchaser is agreeing to be bound by these Terms and Conditions without limitation.

2. Leokid Gift Cards are available in electronic and in plastic form. Both types of the Gift Cards can be purchased on the site www.leokid.com.

3. The purchase of a Gift Card is regarded as a confirmation to make a contract between LLC "Leokid" and the Gift Card Purchaser under present Terms and Conditions. Hereinafter LLC "Leokid" and the Gift Card Purchaser are collectively referred to as the "Parties".

4. Subject to these Terms and Conditions the Gift Card Purchaser has the right to purchase products within the limits of the Gift Card denomination from the assortment and at prices presented in Leokid online store at the date of purchase.

5. Gift Cards are issued to a bearer and may only be redeemed toward the purchase of eligible goods provided by Leokid. Gift Cards may be redeemed by the Gift Card Purchaser as well as by another person, to whom the Purchaser has rendered the Gift Card (hereinafter referred to as the Card Holder). In this case the Purchaser is to inform the Card Holder on these Terms and Conditions.

6. LLC "Leokid" is not liable for the failure of the Gift Card Purchaser to provide the Card Holder with complete, exhaustive and true information on the present Terms and Conditions.

7. Gift Cards are activated at the moment of entering of the Gift Card number while ordering products in the Leokid online store.

8. Gift Cards may be redeemed immediately after its purchase.

9. Gift Cards cannot be returned or refunded.

10. Gift Cards are not replaced when lost or stolen.

11. Gift Cards have no expiration date.

12. The Gift Card denomination is shown on its front side in euro. The sum of money put when purchasing the Gift Card (denomination) is count toward the products payment.

13. Every Gift Card may only be used once within the limits of its denomination, shown on the front side of the Card.

14. In case the Card Holder has chosen accessories to the amount less than the Gift Card denomination, the remaining balance, put when purchasing the Gift Card (denomination balance), is not subject to refund.

15. In case the Card Holder has chosen accessories to the amount exceeding the Gift Card denomination, the remaining amount must be paid with another payment method.
16. When purchasing Gift Cards the Purchaser can not apply the Loyalty Program discount.
17. When purchasing Gift Cards the Purchaser can not apply promotion code discounts.
18. When redeeming the Gift Card the Card Holder can apply the Loyalty Program discount or the discounts active in the Leokid online store.
19. When redeeming the Gift Card the Card Holder can not apply promotion code discounts.
20. No exchange of one or several Gift Cards in order to change the denomination of the Gift Card can be made.
21. Gift Cards are not refillable (no money can be deposited into the card).
22. LLC "Leokid" is not liable for illegal use of Gift Cards, as they are issued to a bearer and don't require to confirm the identity of the customer.
23. By purchasing/using of Gift Cards the Gift Card Purchaser/Holder agrees to comply with present Terms and Conditions.
